# CHAPTER I

# ELY

The surname of ELY is one of the oldest in England. The Cathedral Town and the Isle of Ely in which it is situated an tedate the Norman Conquest and are derived from the Ancient name Helie the last of a line of Kings, or Chiefs who ruled the southern portion of the Anglion Isle centuries before the Christian Era.

Arms: Argent, a fesse engrailled between six fleurs de lis gules.

Crest: (Older) A pheon gules, point up.

(Later) An arm creet couped below the elbow, habited argent, grasping in the hand proper a fleur de lis, sable.

# EXPLANATION OF THE ELY COAT OF ARMS

In heraldry silver denotes purity, eloquence, virginity and innocence; red is the color of war, danger, love of combat and adventure, while black signifies sorrow, sin, mourning and dignity.

The fesse or broad horizontal band across the middle of the shield is called an honorable ordinary, which simply means one of the honorable charges most ordinarily used. It is a mark of noble blood and knighthood and takes its shape from the sword belt of the knight.

The fleur de lis, badge of France, has reference to the French wars in which the family participated.

The pheon which is a broad arrow head. It means belonging personally to the King. All English Government property is stamped with the pheon.

The arm holding the fleur de lis in the newer crest has no significance. It is merely a base for the fleur de lis.

The fleur de lis was a conventional heraldic portrayal of the lily. The name, coming from the Old French signified "flower of the lily." It symbolizes beauty and grace.

There is no motto with the Ely family coat of arms. This is on account of the antiquity of the heraldic grant. The British did not use the motto prior to the Norman Invasion (1066). Its use in Britain came with the Norman Conquerors, who were, needless to say, extremely unpopular at first. As their popularity waxed so did the use of the mottoes among the British. Thus most arms of Anglo-Saxon families which were granted prior to 1200-1250 do not bear mottoes.

In the early Virginia records the name ELY is variously spelled, appearing as Eally, Eley, Ealey, Elly, Ally, and Ely.

I. Thomas Ely, the ancestor of the branch of the Ely family in Southwestern Virginia, was among the early emigrants of the name to the American Colonies and came about the middle of the eighteenth century. According to tradition, Thomas was a young man about twenty-four years of age when he left England for America, and on shipboard met an Irish girl by the name of Jane Smith who was born in Dublin, Ireland, whom he fell in love with and they were either married aboard ship or shortly after they arrived at the port of entry.

There is some evidence that they remained in Pennsylvania for a few years after their marriage, until after the birth of their two oldest sons, before coming to Virginia. After moving to Virginia they settled in Stafford County where they remained for a few years. The loss of the Stafford County records eliminates forever the evidence that would establish more accurately Thomas Ely's place or places of residence during these early years.

Thomas Ely was a soldier in the war between Great Britain and France and received a Land Office Warrant for fifty acres of land to be surveyed in any county within the Commonwealth for his Military service. The place of his residence when he was engaged in this war is not definitely known, but most probably in Stafford County. He was under the command of Colonel Byrd.

The first established place of residence of Thomas Ely in Virginia was not confirmed with documentary proof until 1772. November 23, 1772 Thomas Ely (Eally) of Bedford County purchased land in Bedford County from John Caffery and wife Elizabeth of Bedford County.

"This Indenture made this Twenty third day of November one thousand seven hundred and seventy two between John Caffery of the County of Bedford of the one part and Thomas Eally of the County aforesaid of the other part. Witnesseth the said Caffery for Diver's Good Causes and Considerations, but more especially for and in consideration of the sum of Sixty pounds current money of Virginia...one certain tract piece or parcel of land lying and being in the County aforesaid on the South fork of Beaver Creek containing one hundred acres...With all wood, swamps, meadows, low and high ground, orchards, gardens, houses and all appurtenances....

Thomas Ealie of Bedford County...to Daniel L. Hylton of Henrico County...100 acres lying on Beaver Creek...18 pounds, 12 shillings, 10 pence... (DBK 5-E, P 114)

Thomas Ely and family were residents of Bedford County. Virginia during the Revolutionary war, and Thomas and three of his sons were soldiers in this war. Thomas Ely Sr. served as private in the 5th Virginia Regiment, Continental Line under various Captains under the command of Colonel Josiah Parker and Colonel Abraham Buford. (List of Rev. Soldiers-Eckenrode: Thomas Ealey (5 VR) W.D. 118, 5) Thomas Ely Jr., presumably the eldest son, was killed in this war.

# Tradition — Thomas Ely

"Wounded at Buford's Defeat, feigned death...British soldier said, "This old man is not dead" and ran a bayonet through him...asked, "Why are you fighting against the King?" Thomas replied, I married here, my family is here, my home is here and I think I have a right to fight for my country."

# Memorandum

"The records of this office show that one Thomas Ealy, name also borne as Thomas Eley, served in the Revolutionary War as private in Captain Harry Terrell's Company, also designated Captain Samuel Colston's and Captain William Fowler's Company, 5th Virginia Regiment, commanded by Colonel Josiah Parker. He enlisted March 10, 1777, to serve until March 8, 1778, and was discharged March 15, 1778. Other records show that he enlisted February 25, 1776, for two years. Nothing further relative to this soldier has been found of record."

# Thomas and Jane Ely had twelve children:

In the absence of recorded facts, tradition is the next best source of information: Thomas Ely died two years later from the wound he received, 1780, at Buford's Defeat. Apparently sometime after the death of Thomas, Jane Ely with her large family of children left Bedford County, Virginia and settled in Montgomery County where they received small land grants, and where they lived for several years, until they sold their holdings and made the move to Lee County, Virginia, 1796-98.

After the sale of her land in Montgomery County, Virginia, October 1, 1796, Jane Ely moved with her children to Lee County, Virginia, where they settled and established homes. Presumably Jane Ely lived with her children after coming to Lee County since no records have been found showing that Jane was a land owner in the county. The date of Jane's death is not known nor the place of burial. She was most likely buried on Sugar Run in the old John Ely graveyard, in an unmarked grave. There are a number of unmarked graves in the Robert Ely family graveyard near his old home where Robert and Anne Ely are buried but no records have been found showing that Jane Ely was buried in this family plot.

# WILLIAM ELY

2. William Ely, 2nd son of Thomas and Jane, was born March 25, 1753, according to his statement made when making application for a pension. His declaration for a pension, File No. S 39 493, is preserved in the Revolutionary War Section, Pension Bureau, Interior Department, Washington, D.C., together with other papers relating to his claim. This declaration bears date of March 31, 1819, at which time his age is declared to be 66 years, and his residence Lee County, Virginia. In his second declaration, dated June 27, 1820, Lee County, Virginia, he gives his age as 67 years on "the 25th of March last" and following his first declaration he received a pension certificate dated July 8, 1819, and numbered 12 561. He stated that he enlisted under Captain Thomas Helms on February 15, 1779, and served 18 months or 2 years as Private with the Virginia Troops under Captains Hughes Woodson and Lawson and Colonel Abraham Buford. He was in the battle, May 29, 1780, when Buford was defeated at a place called Hanging Rock (South Carolina), in which battle he was severely wounded in the head and shoulder by a sabre. He was taken prisoner by the British but since he was badly wounded he was paroled in a few days and was permitted to return home. He was pensioned for two years' service. (It is said that he had a silver plate in his head.)

William Ely was married, October 23, 1780, in Bedford County, Virginia, to Mary Rallings (Rawlings, Rollings), daughter of Anthony and Mary Rawlings. This marriage is recorded in the Quaker records, also in the Bedford County Court records; William Thomas, Surety. Anthony Rawlings died in Bedford County, Virginia in 1774. An Inventory of his estate is recorded in Bedford County. The name appears as Rallings, Rawlings, Rollins and Rawlins. One Anthony Rawlings' will is recorded, 1716, in Westmoreland County, Virginia, and the name would indicate that there was a relationship with the Bedford County family, probably a grandfather of Anthony who died in 1774.

Benjamin Rawlings' will is recorded in Bedford County, Virginia, dated Dec. 20, 1776, and proved May 26, 1777. He named his mother: Ann, sister Ann and brother John; Executor: Vincent Glass; witnesses: Archibald Campbell, Jacob Starr and Nathaniel Tanner. (WBK A-1-256) Benjamin was most likely a grandson of Anthony and Mary

William Ely moved from Bedford County, Virginia with his mother and brothers to Montgomery County, where he purchased land adjoining his mother's land. lying at the mouth of Bear Springs, a branch of New River. He sold his land in Montgomery County later and moved with the family to Lee County Virginia. 1796-98, and settled on Sugar Run.

William Ely with others became the owners of thousands of acres of land by survey and entry, lying in Kentucky on the Cumberland River, on Sandy Ridge in the Cumberland Mountains, North Fork of Clinch River, and in Lee County as evidenced by the Entry and Survey Books. Much of this land, if not all, later sold for delinquent taxes.

September 8, 1801, Peter Fisher of Laycock Township in Lancaster County, Penn., conveyed 112 acres of land, lying on Cane Creek, parcel out of 18,555 acre-survey, to William Ely of Lee County, Virginia, on a line with Daniel Dickenson's line, for \$80. (DBK 1-271) and

Sept. 5, 1804 William Ely of Knox Co., Ky. sold the above land to Patrick Napper of Lee Co., Va. (DBK 2-197)

At this date, William Ely was a resident of then Knox Co., Ky., later Harlan County. William Ely, Sr., William Ely, Jr. and Anthony Ely are recorded in the 1810 Knox County census. Later William Ely returned to Lee County, Virginia, where he again became a land owner, bought and sold land, and spent the remainder of his life in the county. (The deeds are all of record.)

After the Elys came to Lee County they became members of the Thompson Settlement Baptist Church. The Minutes of the Church show: Second Saturday in July A.D. 1801. According to appointment the church met and after divine service proceeded to business. First, received brother and sister William and Mary Ely, and Susannah Byars under our watchcare; second, received sister Katherine Ely by letter. (Katherine Ely was the wife of Isaac Ely; Susannah Byars was the wife of William, and a dau, of George Fry, Sr., sister of Barbara (Fry) Ely (wife of John) and Catherine (Katherine), dau, of George Fry, Sr.)

# Memorandum

"Know all men by these presents that William Fly and Mary my wife of the County of Lee and State of Virginia have ordained...by these presents do constitute and appoint Benjamin Hall of the County of Montgomery and State of Virginia our true and lawful attorney for the purpose of conveying all our right...that we or either of us have or may have as heirs of Benjamin Rollins, deceased, who was heir of Anthony Rawlins, deceased...a tract or parcel of land, lying in Campbell County and State of Virginia on Manly Creek...adjoining the lands of Joseph Dinwiddie, Bartholomew Seiy, Charles Glass, and John Jones, to Joseph Dinwiddie...

In testimony whereof we have hereunto set our hands and affixed our seals, this 26th day of June in the year of our Lord one thousand eight hundred and four.

According to the 1850 census, William Ely was 102, born in Pa., and Mary Ely was 103, born in Virginia; Mary Ely, age 53. Mary may have been a granddaughter or her age may have been recorded inaccurately, then she might have been a daughter. William Ely died after 1850, in the year 1853 or before. He is buried somewhere near what is now Hagan in Lee County, and it is said that a headstone marks his grave.

William and Mary Ely had seven children:

May 6, 1856 William Ely deeded a brown mare with increase to Jane Ely, Catherine Ely, John Ely, Elizabeth Ely and Martha Ann Ely, infant children of William Ely, Jr. for the natural love and affection he had for his grand-children.

October 19, 1843 Nancy Berry of Scott Co., Va. sold all her right...in the land, lying on Cumberland Modntain about twenty miles northeast of Jonesville, in the name of William Ely sold for nonpayment of taxes and purchased by William C. Thompson and John Berry, the latter being the husband of said Nancy Berry, who is now deceased, which tract of land contained 32.761 acres...to Dickenson & Couk for \$40. (DBK 9-249)

July 29, 1822 William Ely of Lee County, Virginia sold fifty acres, lying on Martins Fork of Cumberland River in Harlan County, Kentucky to An thony Ely of Harlan County for the sum of one dollar, and same date, Anthony Ely conveyed the same land to William Spurlock for \$100. (DBK A-39, 40)

By 1834 Anthony Ely had moved to Lee Co., Va., and Jan. 3, 1834 conveyed 100 acres, lying on Martins Creek in Lee Co., Va. to Josiah Martin for \$100, and July 17, 1838 Anthony Ely purchased 50 acres from Fielding Seale, Sr. (DBKS 6 & c, pp. 495, 31)

March 10, 1842 Anthony Ely and Elizabeth his wife and William Harris and Catherine his wife sold 49 acres, lying on Martins Creek in Lee County, to Archibald Grubb, and later sold 100 acres, place where Anthony lived, to Edmond Pace for \$500. (DBK 9-46, 944)

August 22, 1853 Elizabeth King sold all her interest in the Estate of William Ely, deceased, who was her grandfather, both personal and real, to Joseph Ely for the sum of six dollars...in the tract known by the name of the old William Ely farm, lying on the western fork of Trading Creek. (DBK 13, 45) Joseph and Rebecca Ely sold the undivided interest in land he purchased of Elizabeth King to Jacob Grabeel for \$22.50. (DBK 13-276)

Sept. 22, 1853 John M. Ely of Gilmore County, Georgia sold one-seventh part of an undivided tract, known as the old William Ely, dec'd, farm, to Robert Napier of Harlan Co., Ky. (DBK 12-587)

At a Court held for Lee County 21 October 1844:

Elizabeth Ely widow of Anthony Ely deceased appeared in court and relinquished her right to the administration of the said decedents estate in favor of Nathan Morgan who made oath as administrator and together with George F. Ely and George Scott his securities, entered into and acknowledged a bond in the penalty of \$500, conditioned as the law directs, certificate is granted the said Nathan Morgan for obtaining letters of administration on the estate of Anthony Ely deceased in due form. (OBK 5-347)

# **JOHN ELY**

3. John Ely (son of Thomas and Jane) was born 1755 in Stafford County, Virginia, died 1839, in February, in Lee County, Virginia. The probate date of his will confirms the year of his death, also other documentary evidence.

John Ely was a soldier in the Revolution, served in the 5th, 11th, and 15th Virginia Regiments, Continental Line. (Echenrode's Roster of Rev. Soldiers, page 99, and Gwathmey's List, page 252) His home was in Bedford County, Virginia during the war, and immediately after the close or before, John Ely moved to Montgomery County where he purchased land, married and established a home and remained for several years. John Ely married about 1783, Barbara Jane Fry, daughter of George Fry Senior and his first wife, name unknown. The 1840 U.S. Census: Barbary Ely, over 80 and under 90. This gives the approximate date of her birth. Barbara Ely died on Sugar Run in Lee County in 1849. The following document confirms the year, and most likely the month:

At a Court begun and held for Lee County at the Courthouse, thereof, on Monday the 16th day of April 1849.

On the motion of John T. Ely and George F. Ely who made oath as administrators and together with Archelous H. Fulkerson and Loring K. Tyler, their securities, entered into and acknowledged a bond in the penalty of \$3000, conditioned as the law directs, certificate is granted the said John T. Ely and George F. Ely for obtaining letters of administration on the estate of Barbary Ely, deceased, in due form.

Ordered that Charles Dougherty, Elias Harbour and Benjamin Dickenson being first sworn before a justice of the peace, do truly and justly appraise in current money the personal estate of Barbary Ely, deceased, and return the appraisement under their hands to the Court. (OBK 6, p. 176)

John and Barbara Ely are buried in unmarked graves on the original John Ely land on Sugar Run in Lee County, Virginia. The graveyard lies East of the home of Miss Lily Orr, now deceased, a descendant of John and Barbary Ely. Other descendants are now residents of the home. David Orr who married Rhoda Ely, daughter of John and Barbary, came into possession of the John Ely Estate by inheritance and purchase, and the place is known as the Orr home and the Orr Cemetery.

While still living in Montgomery County, Virginia, John Ely was appointed surveyor of the road from Thomas Farley's through Narrows on New River to Brown's Ferry on Tom's Creek in 1795.

John Ely was in Lee County, Virginia in the year 1796 as evidenced by the following deed:

September 10, 1796 John Ely of Lee County and State of Virginia sold eighty acres of land in Montgomery County, lying on the Bear Spring the waters of the New River...Beginning at John Alsup's corner...to Ralph Bogle of the County of Montgomery and State of Virginia for fifty pounds...

Witnesses: John Stafford ) Edward Stafford ) Adam Johnson ) John X Elley mark

At a Court held for Montgomery County April 1797...proven by the oaths of the witnesses...

Presumably John Ely returned to Montgomery County in the spring of 1797 where he made preparations for the move to Lee County with the family. John Ely appears again in Lee County where on June 2, 1798 he purchased 693 acres of land lying Powell Valley on Sugar Run from Edmund Smith of Gerrard County and State of Kentucky, obtained by grant, August 10, 1789, for 150 pounds. Witnesses: Samuel Ewing, John W. Crunk, Charles Carter (DBK 1-94). John Ely was the first of the Ely family to appear in the records, and the assumption is that he first came to Lee County on an exploratory trip to ascertain the facts before making the final move with his family. Lee County was still a frontier.

On February 4, 1799 John Ely of Lee County sold land to William Byers of Lee County for \$200, in Powell Valley it being part of a grant issued from the Commonwealth of Virginia in the name of Edmund Smith and by him conveyed to John Ely, containing by estimation 120 acres, corner of David Noe...

William Byers and Susanna his wife sold the above tract of land on December 25, 1804 to David Noe for \$500 (DBK 2-199).

After the sale of this land William Byars and his wife left Lee County. Susanna Byers was a daughter of George Fry Sr. and a sister of Barbara and Catherine (Fry) Ely, wives of John and Isaac Ely.

November 23, 1824 John Ely and Barbara his wife conveyed 156 acres to Thomas Ely, part of the 693-acre tract granted to Edmund Smith and purchased by John Ely, for their natural love and affection for their son and the sum of one dollar (DBK 5-159).

This was probably shortly after Thomas was married. Thomas Ely and family lived here until 1838, when on December 24, 1838 Thomas and Isabel Ely sold the land to David Orr for \$725 (DBK 8-103)

After Thomas and Isabel sold their land on Sugar Run in 1898, they left Lee County, Virginia but nothing further is known of them.

- (2) Mary (Polly) Ely (may not have come in this order of birth) was born in Montgomery County, Virginia. It is not known when or where she died. According to her father's will, she married \_\_\_\_\_\_ Russell, and had children:

Sloan and Polly his wife sold all their undivided interest and shares of all the real estate of which John Ely Sr., deceased, possessed which undivided interests were devised to John Russell, Rachel Lawson, Rebecca Rawlings and Mary Sloan (they were not named in the will) by their grandfather, John Ely, deceased...to David Orr for one hundred dollars.

(3) Nancy Ely (dau. of John and Barbara) was born in Montgomery County, Virginia, 1788, according to the 1850 census. Nancy married in Lee County, about 1806-10, her first cousin, Robert Napier, born 1787 in Montgomery County, son of Edward and Rachel (Ely) Napier. Robert and Nancy Napier are shown in the 1850 census but in different households. Nancy Napier is listed with Jesse Napier, and Robert Napier is shown with the family of Charles Heneger (43), Sophia (40), Julian (20), Jane (19), Sarah (17), Elizabeth (15), Louisa (18), Tinesa (11), Ellender (9), Eliza (4), Margaret A. Spangler (5), all born in Virginia. Robert Napier died Jan. 14, 1860 in Lee County. The date of Nancy's death is not known.

August 22, 1826, Robert Napier applied for an alteration in the road from Isaac Lawrence's to Isaac Dickenson's (OBK 3, 43).

August 1, 1857 Robert Napier and Nancy his wife conveyed 250 acres of land lying on the waters of Trading Creek in Poor Valley in Lee County to Jacob Grabeel for \$250 (DBK 7-359).

No other record has been found showing that Robert Napier was a land

(4) John T. Ely (son of John and Barbara) was born 1790 in Montgomery County, Virginia, and died in Somerset, Pulaski County, Kentucky in 1860. His will, dated February 13, 1852, was proved Jan. 1, 1861, witnessed by Abraham Neff and Orpah Ely. He bequeathed his estate to his wife Margaret, and Margaret qualified as administratrix, Jan. 1, 1861 with David Ely and Caleb Ely her securities. John T. Ely married Margaret

Jones, born 1798, but her parents are not definitely known. Margaret died after 1861. Children:

Ely overseer of the road from William Dougherty's to David Pennington's and Daniel Dickenson was to give him a list of tithables.

September 8, 1831 George F. Ely purchased 105 acres of land from Thomas J. Brown and Susannali his wife for \$400 (DBK 6-305).

John Ely left the following will recorded in Will Book No. 2, Page 79:

- 1. John Ely of Sugar Run in the County of Lee and State of Virginia being of sound mind and body, do make, ordain, and declare this to be my last will and Testament hereby revoking all former wills to wit:
- lst. To my wife Barbara I will and bequeath the one fourth part of all my estate both real and personal, for and during her natural life, and at her death do order and direct that the same shall be divided in manner and form as herein after mentioned.

2nd. To my son Thomas I give and bequeath the sum of Ten dollars as his full and entire portion of all my estate both real personal and mixed to be paid by my executors herein after named in six months after my decease.

- 3rd. To my daughter Nancy Nappier the wife of Robert Nappier I also give and bequeath the like sum of ten dollars as her full and entire portion of all my estate, both personal and mixed to be paid by my executors herein after named in six months after my decease.
- 4th. To the children of my daughter Polly Russell I leave and bequeath the one tenth part of all the balance of my estate, both real and personal to be equally divided among them, and to be paid to them in six months after they respectively arrive at legal age.
- 6th. To my daughter Susanna Warren, I give and bequeath one other tenth part of all my estate both real and personal to be paid to her in six months after my deacease.
- 8th. To my son George F. Ely, I also give and bequeath one other tenth part of all my estate both real and personal to be paid to him in six months after my decease.
- 9th. To my daughter Betsey Woodard the wife of Henry Woodard I also leave and bequeath one other tenth part of all my estate both real and per-

sonal to be paid to her in six months after my decease.

10th. To my daughter Rhoda Orr, the wife of David Orr, I give and bequeath the like one tenth part of all my estate both real and personal, to be paid to her in six months after my decease.

11th. To my son David Ely I give and bequeath the like one tenth part of all my estate both real and personal, to be paid to him in six months after my decease.

12th. At the death of my wife Barbara it is my will and request that such portion of my estate as is herein before bequeathed to her be equally divided among my children to wit Susanna. Rhoda. Betsey, John. George and David and the children of my daughters Barbara and Polly.

13th. Should I survive my wife it is then my will and intention the whole of my estate be divided as herein before mentioned-to wit: to my son Thomas ten dollars, to my daughter Nancy Nappier the like sum of ten dollars, to my daughters Susannah, Rhoda and Betsey and my sons John, George and David the one tenth part of the balance of my estate both real and personal and to the children of my daughter Barbara one other tenth part of such balance of my estate to be equally divided among them and to the children of my Daughter Polly alike one tenth part of all the balance of my estate to be equally divided among them.

I do hereby constitute my sons John and George the executors of this my last will and testament given under my hand and seal this twelfth day of May in the year of our Lord 1832.

At a Court held for Lee County the 18th day of February 1839. (OBK 4-384)

The last will and testament of John Ely deceased was proven by the ath of John Overton, one of the witnesses thereto and continued for further proof. And it appearing to the Court, that William Heiskell the other witness attesting the same resides in the State of Tennessee. On the motion of John Ely and George Ely the Executors therein named, a commission is awarded, to be directed to William B.A. Ramsey, Mayor of the Town of Knoxville in the State of Tennessee, authorizing him to take and certify the attestation of said witness.

J.W.S. Morrison, clerk of Lee County, on February 19th sent a commission from the County Court of Lee County, with the will annexed, to the Mayor of the town of Knoxville, William B.A. Ramsey, to obtain an affidavit to prove the validity of the will.

State of Tenn. Knox County

I William B.A. Ramsey, Mayor of the town of Knoxville in the County and State aforesaid, do hereby certify that William Heiskell who is subscribing witness to the last will and testament of John Ely deceased, and hereto with a commission from the County Court of Lee County in the State of Virginia annexed, this day personally appeared before me at my office in the said town of Knoxville, and made oath the testator (John Ely) signed and published the writing annexed to said Commission as his last will and testament; that the said testator was of disposing mind and memory and that he the said William Heiskell subscribed his name thereto as a witness in the presence of the said testator and at the testators request. Given under my hand and private seal having no public seal at my office in Knoxville this 21st day of February 1839.

W.B.A. Ramsey Mayor of Knoxville

At a Court held for Lee County the 19th day of March 1839 (OBK 4-387).

The writing, purporting the will of John Ely, late of this County deceased, was returned into Court, together with the commission thereto annexed for taking attestation of William Heiskell one of the witnesses thereto, and the certificate under the hand and seal of William B.A. Ramsey, Mayor of the Town of Knoxville, of the execution of the said Certificate

and thereupon the said Certificate being seen and inspected by the Court, the said writing having been proven at the last term of this court by the oath of John Overton the other witness thereto, it is ordered that the said writing be recorded as the true last will and Testament of the said John Ely deceased. An on the motion of John T. Ely and George F. Ely the executors therein named, who made oath thereto, and together with Cornelius Fitts. Nathan Hobbs, David Orr, Charles Daugherty, and Elijah Bishop their securities, entered into and acknowledged their bond in the penalty of Twenty thousand dollars, conditioned as the law directs, certificate is granted them for obtaining a probate of said will in due form.

Ordered that John Hamblen, Charles Daugherty, William Ewing, Arthur Blankenship, and John Fulkerson or any three of them being first sworn before a justice of the peace, do truly and justly appraise in currant money, the personal estate of John Ely, deceased, and return the appraisement under their hands to the court.

# ISAAC ELY

4. Isaac Ely (son of Thomas and Jane) was married in Montgomery County, Virginia, August 17, 1787 to Catherine (Fry) Lucas, widow of Charles Lucas Jr., and daughter of George Fry Sr. and his first wife (surname unknown). (Marriage Book A, p. 19-Consent: George Fry; Witness: Militan Atkins.)

Isaac Ely moved to Lee County, Virginia, 1796-98, with his mother and brothers.

September 10, 1798 Isaac Ely purchased ninety-six acres of land lying on both sides of Sugar Run in Lee County from Lewis Tackett by his power of Attorney, John Lewis (DBK 2-143).

In 1809, Isaac and Catherine Ely conveyed this tract of land to Jesse Woodward (DBK 2-282). Jesse Woodward resided on this tract of land until his death in 1820 and after his death was sold by his heirs.

After the sale of their land in Lee County, Virginia, Isaac and Catherine Ely moved to Claiborne County, Tennessee, where they purchased 100 acres of land from Elias and Sally Lunsford of Claiborne County, October 1, 1810, for \$800, and settled near Powell Station. They remained in Tennessee for several years, but later returned to Lee County, Virginia where Isaac died. Isaac and his wife both may have died prior to 1828.

September 26, 1826, the court ordered that Isaac Ely be exempted from paying county levy and poor rates until his disability is removed. (OBK 3.57).

January 8, 1828, Barton Ely, Solomon Ely, Isaac Ely, Mary S. Ely, Oliver Dodson and John Burgin, said Barton Ely, Solomon Ely, Isaac Ely, and Mary S. Ely, all of Claiborne County, Tenn., and Oliver Dodson of Mc-Minn County, Tenn., said John Burgin of the County of Lee and State of Virginia, conveyed "all our rights of the Real Estate, in the way of land, it heing the land deeded to Isaac and Catherine Ely by Elias Lunsford...100 acres more or less, being an undivided tract, all our parts of said tract," to William Ely of Claiborne County, Tenn. for \$320 (DBK I-35).

(DBK F-98)

Marcellus Ely was a local church minister for the Christian Church (Disciples of Christ) in New Orleans, Charleston, S.C., Puyallup, Tacoma and Seattle, Washington, Vancouver, B.C., Fortuna, Porterville and Vallejo, California.

Paul Marcellus Ely, son of Marcellus I, is a restaurateur, retired.

Mark Ely, son of Marcellus I, is owner and proprietor of a fountain lunch and ice cream store.

Simpson Ely, son of Solomon and Deborah (Harris) Ely, was a traveling evangelist in the middle west.

5. Rachel Ely (eldest dan. of Thomas and Jane) was married in Montgomery County, Virginia to Edward Napier, son of Patrick, Sr. The marriage bond was dated December 28, 1786; Jiney Eley, mother (Book A. 14). Edward and Rachel Napier migrated to Lee County, Virginia 1796-98, however, no records have been found to show that they were land owners in Lee County. Subsequently they moved to Kentucky where they settled on Poor Fork of Cumberland River and became land owners in the present county of Harlan.

September 14, 1833, Edward Napier placed a mortgage on seven hundred acres of land lying on Poor Fork of Cumberland River in Harlan County to secure an indebtedness to Hiram Jones...\$340 was due June 4, 1834...the place where said Napier lived (D. BK. A. 390). Children:

Date of Bond, Feb. 21, 1787, Jane Ealey, mother; William Cromwell, witness.

They moved to Lee County, Virginia with the Ely family, and on June 2, 1798 Rency Napper (Napier) purchased a tract of land, lying on Cane Creek in Lee County, from Edmund Smith, part of a grant to said Smith. (DBK 1. p. 94)

Then on March 7, 1801, Rene Napper and wife Jane conveyed a portion of the above grant, lying on Cane Creek and on Poor Valley Ridge, to Joseph Ely for \$160. (DBK 1, p. 236)

September 24, 1805, Rene and Jane Napier sold 198 acres, lying on Cane Creek, the remaining portion of the Smith grant purchased by Napier, to David Yeary. (DBK 2, p. 232)

Shortly thereafter Rene and Jane Napier moved to Knox County, Kentucky, where they became land owners in what is now Harlan County and

where they resided for several years, later, sometime before 1832, they moved to Perry County. Kentucky. No further records of the family.

7. David Ely (son of Thomas and Jane), b. in Bedford County, Virginia moved to Montgomery County with his mother, then later to Lee County with the family, where he was married to Sarah Claypole most likely the daughter of David and Ann, who were also residents of Sugar Run in Lee

County.

February 10, 1810, David Ely purchased land, lying on Martins Creek from John and Sarah Robinson. (DBK 2-319)

He was taxed for 150 Acres on Martins Creek in 1814. (Land Tax)
He resided at this location for several years, but September 13, 1833 sold two tracts. (DBK 6-440)

The 1830 U.S. Census: David Ely 50 to 60; wife: 40 to 50; 8 children.

# CHAPTER II

# ROBERT ELY FAMILY

8. Robert Ely (son of Thomas) was born March 9, 1773 in Bedford County, Virginia and died August 27, 1843 in Lee County, Virginia. He was married February 14, 1793 in Montgomery County, Virginia by Alexander Ross to Anne McPherson, born November 27, 1774, most likely in Fincastle County, daughter of Alexander McPherson and, according to tradition, Nancy Mortland Bell. No proof has been found to support this tradition. The Court Records show that Alexander McPherson had a wife named Mary, and unless he had a second marriage, Robert and Anne Ely's children had the name of "Nancy" but their eldest daughter was named "Mary," presumably the name of her grandmother McPherson. Robert Ely remained in Montgomery County for a few years after his marriage, where May 3, 1796 he was granted leave to build a water grist mill on his own land on Sinking Creek. This was the same area of the County where Alexander McPherson lived. On October 3, 1799 Alexander McPherson and his wife Mary conveyed 100 A. of land lying on both sides of Sinking Creek in Montgomery County to John Eckols...Anne (McPherson) Ely died May 13, 1846 in Lee County, Virginia.

Sometime after 1796 Robert Ely left Montgomery County, Virginia, came to Lee County and settled on Sugar Run where his mother and brothers were living, and where he purchased 100 acres of land July 8, 1800 from Samuel and Mary Ann (Dennis) Noe for 100 pounds. Robert Ely was an enterprising, ambitious and aspiring young man, and shortly was well-established, one of the largest land and slave owners in Lee County. Eventually he settled a few miles southwest of Jonesville, the county seat of Lee County. He accumulated hundreds of acres of land bordering Powell River, including five tracts purchased, June 17, 1816, from Benjamin Sharp and Hannah his wife, in all, 884 acres lying on the north side of Powell River, for \$2850.

Tract No. 1, 373 acres by grant to Sharp, July 5, 1785, called the Hickorv Grove.

No. 2, 115 acres by deed to Sharp from Henry Hamblen.

No. 3, 87 acres to Sharp, September 20, 1796.

No. 4, 58 acres to Sharp, January 7, 1800.

No. 5, by grant to Sharp, June 7, 1800...(DBK 3-224)

/s/ Benjamin Sharp (SEAL)

/s/ Hannah Sharp (SEAL)

Note: Benjamin Sharp died the following year, 1817.

Robert Ely built a large brick residence overlooking Powell River where he reared his fourteen children who became outstanding citizens of Lee County.

Robert and Anne Ely are buried in a family plot in graves, with limestone covers, lying on a knoll in a grove overlooking the river, where several of their slaves are also buried

Later the old Robert Ely home was destroyed by fire and a new building was erected. Two of the log cabins, "slave quarters," are still standing. The Ely home was near where what is now the Flanary Bridge crosses Powell River. Children of Robert and Anne (McPherson) Ely:

- (1) Isaac Ely (cldest son of Robert) was born in Montgomery County, Virginia, and died 1846-7 in Lee County, Virginia. He married Martha (surname unknown) before 1820. Martha was born 1803 and survived Isaac several years. Sometime before 1831 Isaac and Martha removed to Morgan County, Kentucky where they lived for a few years, and where some of their children were born. Later returned to Lee County, Virginia where they resided on a tract of land deeded to Isaac by his father in 1826, and where Isaac died. September 8, 1847, "Martha Ely, late wife of Isaac Ely, deceased," of Lee County, Virginia sold her lifetime dower in two tracts of land, one where Isaac Ely died and the other where Robert Ely died, to John W.M. Ely. After this sale Martha returned to Morgan County, Kentucky where her children were living.

- Anne, b. before 1821; m. before 1847, Elisha Lundy. In 1847, they sold their interest in the estate of Isaac Ely, deceased, to John W.M. Ely of Lee County, Virginia.

Ely and wife Elizabeth of Morgan County, Ky. sold all his right...being one undivided seventh part of the tract of land upon which "my father, Isaac Ely, lived and died, and on which my mother, Patsy Ely, now lives," to John W.M. At a court begun and held for Lee County at the Courthouse thereof on the 16th day of October 1843.

A writing purporting the last will and testament of Robert Ely deceased bearing date the 10th day of July, 1841, was this day produced in Court by James A.G. Ely and John W.M. Ely, the executors therein named, in order to be proved; and Charles H. Havely by his attorney appeared and opposed the proof of the said Will, whereupon divers witnesses were sworn and examined and the agreements of Counsel on both sides fully heard, on consideration whereby it is the opinion of the court that the said Robert Ely, was not at the time of writing the said will, of sound and disposing mind and memory, and therefore refuse to establish the said writing as the last will and testament of the said Robert Ely deceased. (OBK 5-282)

A writing under the hand and seal of Anna Ely Senr. by which she relinquishes her right to the administration of the said decedent's estate in favor of Robert M. Ely, James A.G. Ely and John W.M. Ely, was proved by the oath of Pleasant Tankersley a witness thereto and is ordered to be recorded. And on the motion of the said Robert M. Ely, James A.G. Ely and John W.M. Ely who made oath thereto according to law and together with Valentine A. Woodard, John T. Ely, John S. Willio, William Adams, David Orr and Hiram R. Ely their securities, entered into and acknowledged a

bond in the penalty of \$8000, conditioned as the law directs certificate is granted the said R.M. Ely, James A.G. Ely and John W.M. Ely for obtaining letters of administration on the estate of Robert Ely Senr. in due form. (OBK 5-283)

Ordered that John Clark, Cornelius Fitts, Wilson Vermillion, Robert Sims and Andrew M. Fitts or any three of them being first sworn before a justice of the peace, do hereby and justly appraise in current money the personal estate of Robert Ely Senr. deceased and return the appraisement under their hands to the court. (OBK 5-284)

(2) Robert M. Ely (son of Robert Sr.) was born August 20, 1795 in Montgomery County. Virginia, and died in Lee County, 1866. He was married in Lee County about 1820 to Margaret (Peggy) Sayers, born 1799, probably in Wythe County, daughter of William and Sarah (Smith) Sayers. After his marriage Robert M. Ely settled in Powell Valley in lower Lee County, where he became well established, a man of considerable wealth for that day, consisting of land and slaves. He took a leading part in community and county affairs, served as justice of the peace over a period of several years. He kept a house of private entertainment.

"This is to certify that Robert M. Ely has been assessed with five dollars to the sum imposed on him by law for the privilege of keeping A house of private Entertainment at his Dwelling in Powels from this time until the next April Court.

Given under my hand this the 15 June 1857. Robert P. Spencer Comm of the revenue for Lee Co."

Robert M. and Margaret Ely had several children but all died in infancy except one son

- William S. (probably "Sayers") Ely was born December 29 1826 and died May 13, 1860, of typhoid. William S. Ely was a lawyer and practiced in Lee County until his death. His father, Robert M., was the administrator of his estate, and Alexander H. Brant, G.H. Hoskins and Daniel Littrell made the appraisal. William S. Ely married about 1855 Elizabeth Ball, born June 30, 1831, daughter of William and Elizabeth Smith (Gibson) Ball, who died April 6, 1856, and left an infant son:
  - Robert M. Ely, (known as "Little Bob" Ely), born March 11, 1856 and died July 13, 1880.

Robert M. Ely left the following undated will, in which he disposed of his personal property:

In the name of God Amen. I Robert M. Ely of the County of Lee and State of Virginia, being weak of body and in bad health but of firm and deposing mind, make this my last will and testament, revoking all others. All my debts are to be settled by my Exrs & then, in the first place I will unto my beloved wife Peggy four negroes to be chosen by herself; also all monies gifts &c by her father bequeathed to her, she is to keep, also I will all my household and kitchen furniture remain with my beloved wife during her natural life also my stock of hogs to be taken care of and kept in the clover fields for her support, that she may not want & my horses for the use of the farm, my cattle also for the use of the farm and her. There is some five or Six hundred dollars in gold in the house. If there be enough moneys without this to pay all debts, then I will one half of it to my wife. To my beloved Grand son Robert I will eight young negroes to be chosen for him by William Ball & Peggy my wife. I also give him my fine mare purchased of Enoch Bush as she is gentle for him to ride. I also will he have one half of the gold on hand should there be enough money besides to pay my debts. My Exectors can sell at any time any stock or anything not herein bequeathed. I appoint my wife Peggy, William Ball, M.S. Ball & A.M. Ely my Executors to see things be faithfully done, having full confidence myself the subscribing witnesses. My own signed name

# Deed Book 13, Page 258 - 19 December 1856

George S. Ball and wife Lucretia A. conveyed three tracts of land, containing 640 acres, adjoining Robert M. Ely's land and the Beaty land, to William S. Ely for \$5000. Presumably this is the land where Robert Ely, son of William S., built his large brick residence.

#### Deed Book 15 - Page 336

Pursuant to an order of the county court of Lee County, Virginia, dated November 20th 1865.

We the undersigned commissioners proceeded on the 10th day of April 1866, to lay off and assign to Mrs. Margaret Ely, widow of Robert M. Ely, deceased, her dower interest in and to the lands which the said Robert M. Ely, deceased, died seized and possessed and by leave to report, we began at a rock on the State road at or near a corner of Colstons' land and ran thence with lines of the same ... to Indian Creek ... to a corner of William S. Ely's (deceased) land ... Beginning ... containing about 540 acres and including the mansion house and most of the other buildings.



May 10, 1908 in Lee Co., Va., son of J.C. and M. Taylor. Susan (Gibbs) (Ely) Taylor d. Feb. 14, 1946. Susan and Thomas A. Taylor are buried in the Kincaid Cemetery, near Ewing, Va. Thomas A. Taylor was engaged in the mercantile business. They had one son.

Sometime around 1877-8 Robert M. Ely built a large handsome Colonial style brick residence in Powell Valley on the Ely Estate, where the family resided and where his youngest daughter, Annie, was born, the Taylor family, including the Ely daughters resided here for several years. Eventually, the estate was divided among the Ely daughters, and the youngest daughter, Annie, inherited the home and surrounding land which she later sold. The house has been restored, furnished with antiques, and is now the most out-

standing place in Lee County-including the house and grounds.

Surgener of Lee County are held and firmly bound unto the Commonwealth of Virginia in the sum of Eight Thousand (\$8000) Dollars ... we bind ourselves jointly and severally and firmly by these presents, and we as to this bond waive our homestead exemptions. Witness our hands and scals this 4th day of September 1882 ...

The condition of the above obligations is such, that whereas the above bound S.M. Ely has been appointed guardian for Margaret, Mary and Annie Ely, minor heirs at law of Robert M. Ely, Jr., deceased, ...

Now if the said Susan M. Ely, shall faithfully perform and discharge the duties of her office of Guardian aforesaid, then the above obligation to be void, otherwise to remain in full force and virtue.

After the second marriage of Susan M. Ely, Thomas A. Taylor was appointed guardian for Margaret Ely, Mary Ely and Annie Ely, minor heirs ... Taylor and others executed a bond in the sum of Ten Thousand (\$10,000) Dollars, 25th day of August 1885.

To the Hon. H.S.K. Morrison, Judge of the Circuit Court of Lee County, I do constitute and appoint my mother, Susan M. Taylor to act as my guardian. I am 15 years old. This the 8th day of September, 1890.

(3) George R. Ely (son of Robert, Sr. and Anne) was born Aug. 19, 1797 in Montgomery County, Virginia, and died September 2, 1886. He was married in Lee County about 1823 to Mary Blankenship, born April 4, 1807 in Tazewell County, Virginia, and died March 2, 1870, Lee County, daughter of Arthur M. Blankenship and his first wife, Mary Muncy, daughter of Skidmore and Mary (Scott) Muncy (Muncey). Mary Scott was a daughter of Samuel and Ann Scott of Augusta County. She was named in the will of her father. Numerous records are found in the early records of Augusta County relating to the Scott family. After the death of Mary, George R. Ely married 2nd, May 4, 1872, E. Jane Martin, born 1845, daughter of John.

George R. Ely was a local Methodist minister and also engaged in farming. He owned several large tracts of land lying on Sugar Run and in Poor Valley in Lee County at various times, bought and sold land, and was a prosperous farmer. He made his home on Sugar Run. August 19, 1848 he deeded fifteen acres and personal property to his brother James A.G. Ely for the sum of one dollar.

May 17, 1847, George R. Ely made application for a road from his house to Arthur Blankenship's—the Court ordered that Arthur Blankenship. John Taylor and James Redwine view the road and make a report to the Court (OBK 6, p. 20).

In 1856, George R. Ely and wife Mary deeded one hundred acres lying on Chestnut Ridge in Lee County to their eldest son, Arthur Campbell Ely for five hundred dollars (DBK 13, p. 158).

"Know all men by these presents that I George R. Ely of Lee County and State of Virginia have this day sold and delivered unto Robert M. Ely all my undivided fourteenth part of the land Possessed by my father Robert Ely deceased belonging to me as an air of the said Robert Ely deceased for and in consideration of the sum of three hundred dolars to me in hand paid to which land I bind my self to make unto Robert M. Ely awarnt title—and also my intrust in this present years grain crop of corn given under my hand & seal this 6th of November 1843

(3) Alexander McMillen Ely (son of Andrew and Esther) was born Sept. 11, 1859. He was a prosperous farmer, active in civic and political affairs of the county, and later elected Treasurer of Lee County. He was married twice, first, about 1881 to Mattie E. Susong, born Jan. 12, 1861 in Washington County, Va., and died Aug. 2, 1886 in Lee County, daughter of Mahlon S. and Ellen M. (Buchanan) Susong. Mahlon S. Susong and Ellen M. Buchanan were married in Washington County by James King, Nov. 2, 1845. Alexander M. Ely married, 2nd, Nov. 19, 1890, Elizabeth Richmond, daughter of M.D. Richmond. Sometime before 1915 Alexander M. Ely sold his holdings in Lee County and removed to Loudoun County, Virginia and settled near Leesburg, where he and his wife died. Their children were:

- 3. Robert B. Ely, a lawyer. After his marriage and the birth of two children Robert Ely returned to Lee County where he was born and settled in Jonesville for a few years. While living here he was elected Commonwealth's Attorney of Lee County, serving one term. Later he left Lee County and settled in the Washington, D.C. area where he died.
- (4) Charles Robert Ely (son of Andrew McMillen and Esther) was born Sept. 28, 1861 in Lee County, Virginia. He married in Lee County, Sept. 8, 1886, Lorinda R. McDowell, b. August 27, 1865; d. May 25, 1903; buried in the McDowell family cemetery. White Shoals, Lee County, Lorinda Rozella McDowell was the daughter of John McDowell (b. Feb. 12, 1833;

d. Feb. 17, 1895) and Susannah Shelby Jones (b. Nov. 18, 1834; d. about 1904), daughter of James Jones (b. Dec. 20, 1805; d. Oct. 27, 1854) and Lorinda Warren, (b. Nov. 4, 1806; d. July 14, 1886). (See the McDowell and Warren-Jones Families). Sometime after their marriage Charles Robert and Lorinda Ely left Lee County, Virginia, and in 1893 they were in Nebraska. - Rose Edith Ely, b. Sept. 11, 1897, Floyd, Texas; d. Oct. 6, 1967, after a lengthy illness; m. at Cumberland Gap, Tenn. by I.S. Anderson, William Patton Tritt, Nov. 27, 1915. She was P.M. at Woodway, Virginia for 27 years. (See the Tritt Family)
- (7) John C. Ely (son of Andrew M. and Esther), b. Feb. 6, 1868; m. Nov. 23, 1904, Mallie Bales, b. 1869, dau. of Jonathan and Sarah A. (Crockett) Bales. The marriage record gives the name. "Melvina O. Bales." John C. Ely was Deputy Treasurer under his brother Alexander M. Ely, Treasurer, at the time of his marriage. John C. Ely built a large home a short distance northeast of Jonesville where he resided after his marriage until 1915 when he sold the home and farm to J. Paris Albert, now owned by Joseph A. Wolf. After the sale of his holdings in Lee County he removed to Loudoun County, Virginia and settled at Leesburg where he engaged in farming, and where his wife died in 1926. After the death of his wife, John married a second time. The name of his second wife is not known nor the date of his death. After the death of her parents Rose Ely, daughter of Charles Robert Ely and Lorinda R. McDowell, lived with the John Ely family until her marriage.
- 5. Thomas Smith Ely (son of Alexander M. and Mary (McMillen) Ely) was born March 23, 1837 (1839 is also shown) at the old Ely homestead about five miles west of Jonesville in Lee County, Virginia, where he spent most of his life, and where he died December 2, 1907. He clerked in his brother Andrew M. Ely's store at Walnut Hill in Lee County for about six years when a young man, and while here, he met Susan Malinda Willis whom he married March 9, 1858. Susan Malinda Willis was born December 4, 1841 and died July 28, 1901, daughter of John S. and Susan Willis of Walnut Hill. Thomas S. Ely served in the Sixteenth Virginia Regiment in the Confederate Army during the first two years of the war. Later he moved to the old Ely farm where he became a prosperous farmer. He was elected sheriff of Lee County and served two terms (eight years), and executed all the papers in the Absalom Russell murder case. He was married three times. After the death of his first wife in 1901, he married, June 15, 1902, Rebecca E. Hickam, born 1841, daughter of Thomas J. and Catherine (Allen) Larmer. His third wife was C.L. Bartley, born 1867, whom he married February 5, 1905. The Thomas Smith Ely home was near the Wesley Chapel Church, and he and his family were active members of the Methodist Episcopal Unurch, South, for many years. Subsequently the North and South Methodist Churches merged.

Dr. Ely as a boy attended the country schools near his home, graduated in 1900 from the Jonesville High School, and then was a student at Emory and Henry College until ill health caused him to leave at the beginning of his junior year. After recuperating on the home farm until 1905, he entered the Medical College of Virginia, Richmond, and was graduated Doctor of Medicine in 1909. For one year he was intern in the Sarah Leigh Hospital at Norfolk, Virginia He returned to Lee County, Virginia where he hexame busy with a general medical and surgical practice at Jonesville, where he resided, and in Lee County. Two children were born to them:

  - 2. Thomas Southgate Ely, born June 8, 1914, M.D. Dr. Ely resides in Jonesville, Virginia where he practices medicine in the town and the county. # CHAPTER III

# JOSEPH ELY FAMILY

9. Joseph Ely (son of Thomas and Jane) was born Nov. 12, 1775 in Bedford County, Virginia, and died Nov. 2, 1827 in Lee County, Virginia, leaving a will, dated February 17. 1827. He married. 1799. Frances (Fanny) Hix (Hicks), born Nov. 26, 1778 in Washington County, Virginia and died April 16, 1861 in Lee County, daughter of Nathaniel and Jane (Scott) (Chrisman) Hix. The birth date is recorded in the Russell Family Bible and the death date in the Lee County Death Register. Both are believed to be the correct dates, however, they do not correspond with the tombstone inscriptions.

May 31, 1861 (Will Book 2, Page 427, Lee County): We, Henry Graham, Elkanah Flanary and Tobias Pennington, first being duly sworn, do appraise all the personal estate of Frances Russell, deceased. July 17, 1861-This Bill of Appraisement of the personal property of Frances Russell, deceased, was this day admitted to record.

Teste: William S. Saul D.C.

Frances Ely was married to John Russell, Senior, by Andrew Hunter, June 5, 1831. (Lee County Marriages.)

"John Russell and Frances Russell (nee widow Ealy (Ely) his second wife was married June 5th day 1831." (Russell Family Bible.)
Tombstone Record: "b. April 7, 1780; d. April 17, 1860; 80 years."

Joseph Ely and Frances (Ely) Russell are buried in the Ely family graveyard on the old Ely homestead, now known as Riverview Cemetery, overlooking North Fork of Powell River, Pennington Gap, Virginia.

After his marriage Joseph Ely settled in the Cane Creek area of Lee County where he first purchased a tract of land lying on the Poor Valley Ridge from Rene and Jane Napier, being part of the land they purchased from Edmund Smith in 1798. Subsequently Joseph Ely sold this tract of land and purchased a tract lying on both sides of North Fork of Powell River from Thomas and Sarah Stewart, adjoining Isaac Hisor and Esward Pennington, where he built and

established his home overlooking North Fork of Powell River. Joseph Ely obtained additional land and engaged in farming with slave labor. He reared a large family of children who intermarried with other leading families of Lee County, Virginia and Harlan County, Kentucky.

Joseph Ely was well established and took an active part in the affairs of the County. He was frequently called upon for public service. His home was a landmark in the county. In cutting and building roads and ascertaining locations, Joseph Ely's home was frequently referred to as: passing "Joseph Ely's."

Joseph Ely died November 2, 1827 at the age of 52, leaving a large family.

Pursuant to an order from the County Court of Lee dated the 25th of December 1827 to us directed we have proceeded after being sworn for that purpose to appraise the personal property of Joseph Ely, deceased, and we do appraise said property to the sum of \$2,127.50 given under our hands this 23 of February 1826. (This should be 1827)

(1 negro boy \$250) Edward X Pennington (2 negro girls \$700) Edward Smith John Russell. Sen.

#### Virginia

At a Court held for Lee County 25 December 1827. On the motion of Fanny Ely the Executrix named in the will of Joseph Ely, deceased,...made oath thereto and together with Benjamin Dickenson, George F. Ely and Robert Ely her securities...acknowledged a bond in the penalty of \$3000 conditioned as the law directs certificate is granted her for obtaining probate of the said will in due form (OBK 3 p. 125)

# Will of Joseph Ely

I Joseph Ely of Lee County and State of Virginia do hereby make my last will and Testament in manner and form following that is to say. First, after the payment of my debts and funeral expenses I give to my wife Fanny Ely, the plantation whereon I now live with all my land Estate goods chattles of what nature soever until my youngest child arrives to the age of twenty one years then I desire that all my lands be equally divided according to quan tity and quality with my four sons, Hiram, Joseph, Nimrod and Andrew J. Ely reserving the third part to my wife for and during the term of her natural widowhood. Also I desire that my wife give to my children that is now living with me as they get married or arrives at the age of twenty one years the same quantity of property as to make them equal with those of my children that are already married. It is also my desire that when my youngest child arrives to the age of twenty one as above mentioned That the residue of my property be equally divided with all my children, with reserving one third part to my wife for and during the term of her natural life and after her decease to be equally divided with all my children-and lastly, I do hereby constitute and appoint my wife Fanny Ely executrix of this my last will and Testament hereby revoking all others or former wills or testaments by me heretofore made. In witness whereof I have hereunto set my hand and affixed my seal, this 17th day of February in the year 1827.

THE LAST LETTER OF A DYING CONFEDERATE SOLDIER, IN PRISON, TO HIS WIFE

Hospital Ward No. 10, Camp Douglas, Illinois January 12, 1864

My dear wife and children:

I have often been permitted to write to you since I joined the army, but this is the last you will ever hear from me. I have been sick of typhoid fever about four weeks, my eyes are now swimming in death and I die in a few hours. I am quite sensible of everything and in my proper mind. But I shall soon bid farewell to earth with all its fruits, but while I am bidding the last farewell to earthly friends, angels are beckoning me away. They are around my bed. They are in my room waiting to take my spirit home. All is well and all is well. I was vary anxious to live to get home again to advise my children once more, but since it is the will of my Father to take me from here, I am resigned to his will. My dear wife I want you to teach my little children the lessons of the Lord. I want you and them to follow my foot steps and meet me in that sunbright clime, the home of the just whose name is heaven. I will soon be gone to dwell with the Angels of God forever. Oh what a heavenly breeze. Give the children as good education as you can and always instruct them the way of righteousness and you my dear wife take the instructions of your father in regard to your affairs. I am bound to stop writing but I must necessarily close my letter and my eyes in death. My dear companion and children farewell.



And after her decease and her just debts and Funeral expenses are paid I then desire one third of all my estate at that time both real and personal to be equally divided between my wife's brothers and sisters if living, I will give their names, Tobias S. Pennington, Virginia Garrison, America Graham, now as Tobias S. Pennington and Virginia Carrison has already deceased I desire that their heirs shall draw their part, now if America Graham shall depart this life before the above distribution of my estate is made I will that her heirs shall draw and equally divide her part I desire and will the other two-thirds of my estate both real and personal to be equally divided between my brothers and sisters if living if not I desire the heirs of those that may have deceased before this distribution is made of my estate to draw their Father's or Mother's part, and equally divide it between them. I will give the names of my brothers and sisters above referred to Jane Smyth, Elizabeth Branson, Hiram Ely, Rachel Jones, Barbara Parsons, Frances Bailey, Nimrod C. Picture # 4 Nimrod Chrisman Ely Log House - built about 1837-8—still standing and occupied.



Susan (Ely) Young rode horseback to visit the J. Morrison Smyth family, near neighbors, and on her return trip home, the horse became frightened and ran into a barbed wire fence injuring her seriously. The injury proved to be fatal and she died within a few days.

1. Elizabeth (Betsy) P. Ely (eldest dau. of Nimrod C.) was born Dec. 9, 1838 and died Sept. 6. 1892. She was married March 12. 1857 to Chadwell B. 5. James P. Smyth (son of John and Jane (Ely) Smyth) was born about 1828-9 near the present town of Pennington Gap. The name is also spelled "Smith" in many of the records. James died July 8, 1862 at the age of 33. The Lee County Death Register shows that he was shot. (Believed by renegades in the Civil War.)

James P. Smith married Martha J. Myers, born about 1833-4 in the Cane Creek community, near the present town of Pennington Gap, daughter of John and Rachel (Harsh) Myers.

Marriage Certificate: "I certify that James P. Smith and Martha Myers were joined together in the holy state of matrimony on the 16th day of October 1851 by me.

License issued October 7, 1851. Recorded in Marriage Book A-1, Page 30, Lee County.

After the death of James, Martha J. (Myers) Smith (age 30) was married February 8, 1864 to William Taylor (age 24), born in Patrick County, Virginia, son of Josiah and Ruth Taylor. They were married by James Lloyd.

James P. Smyth's personal property was appraised the 29th day of August 1862 by James T. Lloyd, A.D. Stout and A.J. Wilson (WBK 3, 158). His father, John Smyth, was the administrator and the Bill of Sale was admitted to record, 26th day of December 1865 (WBK 3, 154). Teste

George Cole, son of David Mason Cole and Jane Crusenberry, was born in Lee County, Virginia Aug. 21, 1851, died June 9, 1987 in Indiana. Sometime after 1876, George Cole and his wife Sarah Catherine left Lee County, Virginia, and settled near West Liberty, Kentucky for a few years.

Later, before 1886, moved to Indiana and first settled at Hobbs Station. Still later they lived at various other places in Indiana. George and his wife died at Indiana, place not definitely known.

# CHAPTER IV

# GEORGE - SARAH - MARGARET ELY TROTTER - CHANCE - BRANSON FRANCE - MALONEY - NAPIER

10. George Ely, son of Thomas and Jane, was born 1777-80 in Bedford County, Virginia. The records relating to his birthdate do not agree and the exact birthdate cannot be confirmed. He died April 19, 1855 in Lee County, Virginia. His will, dated August 20, 1846, witnessed by Matthew Warren, V.A. Woodard and David Orr, was proved April 30, 1855. He was married twice, 1st, to Mary (Polly) Trotter, born in Greenbrier County (now West Va.), daughter of James and Mary Trotter, whom he married in Lee County about 1800, and who died prior to August 21, 1821 on Sugar Run in Lee County. The date is confirmed by the will of her father, James Trotter. George Ely acquired considerable land holdings, lying in the Sugar Run area of Lee County adjoining the land holdings of James Trotter, and he was one of the well-established citizens of the community.

March 17, 1834, the Court ordered that George Ely, Sr. be appointed overseer of the road in the room of John Sims and that he keep the same in repair with said Sims list of hands. (OBK 3 - 532)

George and Mary (Polly) Trotter Ely had nine childrn: Nancy, James, Thomas, William, Betsy, Isaac, George, Polly and Preston. The children were named in their grandfather Trotter's Will.

John M.P. Ely was called "Preston" in his grandfather's will, also in later records. See the Bays Family.

After the death of Polly Trotter, his first wite, George Ely married second about 1822, Lydia Housen, born 1793, and died June 12, 1851 at the age of 58, according to the tombstone inscription. George Ely continued to live on Sugar Run for several years after his second marriage, but eventually he sold all his land holdings on Sugar Run and purchased a tract of land con-

taining 224 acres lying on both sides of Cane Creek in 1842 from Ransom Russell and wife, Elizabeth Jones, adjoining the lands of Isaac and John Russell, where he established a new home for his second family, and left to his two sons by his will. He and Lydia are buried in the family graveyard on this farm located about a mile from the present town of Pennington Gap. The graveyard lies on the North side of Cane Creek, also North of the Louisville & Nashville Railroad.

I give what may remain of her part of estate, both real and personally likewise to my sons above named Joseph and David.

I leave to be given to my daughter Betsey one hundred dollars which is for her grandfather Trotter's land also to my son George one hundred dollars for the Trotter land one horse worth about fifty five dollars to be paid at my death to my daughter Nancy one dollar to be paid at my death also to my son Thomas Preston and my daughter Polly one dollar each to be paid them at my death.

I now request my sons Joseph and David to respect their mother and ese her well during her lifetime.

In witness whereof I hereunto set my hand and affix my seal this 20th day of August 1846.

11. Sarah Ely (dau. of Thomas and Jane) married August 1, 1793 in Montgomery County, Virginia, John Webb, son of William. John Webb and Sarah moved to Lee County and settled on Sugar Run where John purchased a small tract of land lying and being on the waters of Trading Creek, corner to David Claypool, for 40 pounds from George Tackett of the County of Lincoln and State of Kentucky, September 23, 1800 (DBK 1 191).

John and Sarah Webb lived on this land until February 23, 1808 when John Webb and Sally his wife of Lee county conveyed the land to John Ely tor \$140...

# TROTTER

There were several different coats of arms borne by families named Trotter in England. The following description of the coat of arms given here is that of the family of Byers (now Byers Green) Hall, county Durham, which seated there in the 14th Century.

ARMS: Argent, a chief ermine over all a lion rampant azure.

CREST: A lion's head erased argent collared ermine. MOTTO: Fortis non ferox. (Burke's General Armory.)

N.B. - In the Heraldry by Guillim, 1724, the above arms and crest is the only one given for Trotter, which is a Saxon surname, the Winton Domesday Book showing that Robart Trotar was a tenant-in-chief of King Edward the Confessor.

I. William Trotter, the immigrant ancestor of the branch of the family that eventually settled in Southwestern Virginia, according to tradition, came to America with two brothers from England around the middle of the 18th Century. He was living with his family in a fort in Greenbrier County at the close of the Revolutionary War. Greenbrier County was formed in 1778 and Monroe from Greenbrier in 1779. The tax records, 1783, show William Trotter a resident of Greenbrier County with 5 whites and 2 blacks.

According to Eckenrode's roster of Rev. soldiers, William, James, Isaac and \_\_\_\_ Trotter were soldiers in the Revolutionary War.

William Trotter migrated to Russell County, Virginia where he entered 100 acres of land assignee of John Frazier in 1790. He served with a detachment of Militia from Powell Valley under Lieut. Matthew Willoughby in 1792.

William Trotter received a grant from Virginia of 96 acrcs, lying on Trading Creek in Lee County, July 29, 1796, and he died in Lee County, 1797-8, at the age of 90. William Ewing, Samuel Ewing and Samuel Adams appraised the Estate of William Trotter and his son James was appointed administrator of the estate. Presumably his wife had died since she is not mentioned in the settlement of the

1. James Trotter, only known son of William, was in Greenbrier County in 1783 and in Russell County by 1786. in the extreme western portion on the frontier which later became Lee County, 1792. At a Court held for Russell County the 10th day of August 1786, the Court ordered that James Trotter be overseer of the main road from "the foot of powels ridge to the ford of Powels river and that Thomas Carter gent. give him a list of tithables." James Trotter signed the petition in 1792 for the Division of Russell County. After settling in Lee County he acquired considerable land holdings by grant and purchase. He purchased more than 600 acres from Charles and Ellender Cocke. As heir of William Trotter, deceased, he conveyed land, granted to William, to Aquilla Noe and David Claypool. He settled in the Sugar Run area of Lee County and his land lay on the waters of Trading Creek. In 1815 he was taxed for 1358

After James Trotter settled in Lee County, he sold land in Monroe County. The following deed:

This Indenture wad made this \_\_\_\_\_ day of \_\_\_\_\_ in the year of our Lord one thousand and eight hundred and \_\_\_\_\_ between James Trotter \_\_\_\_ his wife of Lee County and State of Virginia of the one part and John Daugherty of the County of Monroe and the State aforesaid of the other part. Witnesseth that the said James Trotter for and in consideration of the sum of \_\_\_\_\_ Dollars current money of the United States to him in hand paid, the receipt whereof he doth hereby acknowledge, have granted...unto the said John Daugherty...one certain tract or parcel of land lying and being in the said county of Monroe formerly Greenbrier. It being the land the said James Trotter formerly lived on and the same which the said John Daugherty now lives on adjoining the land of James Simpson containing 300 acres more or less and granted to the said James Trotter from the Commonwealth of Virginia by patent bearing date 10 day of April 1786 and bounded as followeth to wit...

At a Court held for Lee County the 27th day of February 1810. Ordered that James Trotter be exempted from paying poll tax and county levy on account of his age and bodily infirmities. Recorded in Order Book (now) 1, Page 65

The surname of Mary Trotter, wife of James, is unknown, also the exact date of her death is unknown, but she died prior to 1821. James Trotter's will is dated August 21, 1821. He named all his children and his grandchildren, children of his deceased daughter, Polly Ely who married George Ely, Sr. in the will. The probate date of the will has not been found.

Mary Trotter Daugherty died in 1883. (See the William Daugherty Family.) Sometime before 1836 Isaac Trotter with his family removed to Indiana and settled in Hendricks County.
- (3) James Trotter, Jr. married Elizabeth \_\_\_\_\_\_. Between 1812 and 1818 he went to Indiana. August 11, 1818, Isaac Trotter and Rebeckah, his wife, of Lee County and State of Virginia, and James Trotter, Jr. and Elizabeth, his wife, of Monroe County and State of Indiana, conveyed 300 acres of land, part of a grant to Joshua Butcher by date, September 14, 1792, and conveyed to James Trotter, Sr., and by him to Isaac and James Trotter, Jr. by deed. April 19, 1819, to John Belcher of Tazewell County and State of Virginia. (DBK 3-420)
- (4) Mary (Polly) Trotter married in Lee County Virginia about 1800, George Ely, Sr., son of Thomas and Jane Ely. Mary Ely died prior to 1821. They had nine children all named in their grandfather Trotter's will.

She married John Sims, son of Robert, b. Feb. 26, 1794; d. Jan. 6, 1877.

John and Nancy Noe Trotter had a son, John Trotter, Jr., b. 1805. October 28, 1835, John Trotter, Sr. deeded a tract of land to his son, "devised to me by my father, James Trotter, Sr.", for \$600, and Nov. 13, 1835, deeded personal property "for the natural love and affection which I have for my son and \$5." (DBK 7 - 127-8)

(6) Elizabeth (Betsy) Trotter, youngest dau, of James 1, was born in Monroe County and died in Lee County, Virginia after 1860, unmarried. In the 1860 census she was listed with the family of Nancy and George Scott, age 79.

July 10, 1836. Elizabeth Trotter for herself and for Isaac Trotter conveyed 66 acres of land to Benjamin Dickenson for \$200. (DBK 7-312)

September 19, 1836, "I, Issac Trotter of the County of Hendricks and State of Indiana do make and appoint Charles Daugherty, my son-in-law, of Lee County and State of Virginia my power of attorney to convey all the lands, lying on Powell River sold to John Jayne..." (DBK 7-248)

# **CHANCE**

The Chance family descends from a very old English family. The name was Chaunce until the time of William Chance, who was baptized October 4th, 1660. Thereafter the name appears in its present form—Chance. According to Burke, the family of former times was very numerous in and about Bromsgrove, Worcestershire, England. A history of the family has been published, entitled Chance of Bromsgrove and Birmingham, by James Frederick Chance, privately printed.

The pedigree begins with Richard Chaunce, of Bromsgrove, died 1558 (will dated I September, proved 28 November 1558), leaving three sons: Thomas, Richard and William, the eldest son.

Arms: Gules, a saltire vair between two fleurs-de-lys in pale and as many towers in fess argent.

Crest: A demi lion rampant gules, seme of annulets or, holding between the paws a sword erect, entwined by a wreath of oak all proper.

Motto: Deo non fortuna

(Burke: "General Armory", 1878 edition, page 184, and Burke: "Peerage And Baronetage.") (Registered In The College Of Arms).

The first records of the branch of the family that eventually migrated to Lee County, Virginia, appear in the federal census of 1790, showing Stephen Chance as a resident of Wayne County, North Carolina, head of a family. Richard and Thomas are recorded as heads of families in N.C. 1790, also Esther Chance (Craven County,

1790) 2 f 18 slaves.

I. Benjamin Chance, the first known ancestor with documentary proof of this branch of the family, was in North Carolina with a wife named Rachel, before the Revolutionary War. He was most likely the brother of Stephen Chance who was shown as head of a family in 1790. "Stephen" appears to be a family name.

1. John Chance, son of Benjamin and Rachel, was born in N.C. and died in Lee Co., Va., Feb. 27, 1857 at the age of eighty-two of old age. (Lee Co. Death Register.) He married in N.C. prior to 1803, Mary Morton, b. 1780. According to the 1830 Lee County census, John Chance, a resident of Lee County, 50-60; wife, 40-50. Mary Chance died after 1860. She is listed in the 1860 census, b. in N.C., age 80, in the home of her daughter, Charity Speak. The Mortons descend from a prominent North Carolina family. John Chance was probably in Grayson Co., Va. before coming to Lee County, and the records also indicate that he was in Greene County, Tenn.

After coming to Lee County, Virginia John Chance began acquiring land by purchase, Nov. 30, 1833, Robert C. Fulkerson conveyed 200 acres of land, lying on the head waters of Lick Branch, affluent of Martins Creek, corner of Nicholas Speak's land and in a line with William Taylor's land, granted to Fulkerson, to John Chance for \$100 (DBK 6-468)

Jan. 8, 1844 John Chance deeded one half of the 200-acre tract (100 A) to his son Stephen Chance for the natural love and affection which he had for his son Stephen chance and further consideration of \$100. (DBK 10-393)

April 20, 1846 John Chance made a deed to his daughter Charity Chance in consideration of \$100 and for a number of years faithful service rendered to him, the said John Chance, and in consideration of the natural love and affection for his said daughter, 100 acres, southwest one half of 200 acres, lying on Martins Creek and the same whereon John Chance resides...purchased 20 Nov. 1833...signed: John Chance (Seal)

- (3) Stephen Chance (son of John and Mary), m. Mary \_\_\_\_\_. Feb. 11, 1857 Stephen Chance and Mary his wife conveyed 100 acres...one half of 200 acres that was deeded to me by "my father John Chance" to Vincent Lowe for \$800. (DBK 13 - 260)
- (4) Charity Chance (dau. of John and Mary) married Andrew M. Speak after the death of his first wife, Lavina Chance, sister of Charity. They had two children, John Speak, d. Nov. 3, 1859; Martha E. Speak, b. 1859-60.

Andrew M. Speak and his wife Charity moved to Kentucky after the death of her mother and settled in Grant County, and Sept. 9, 1869 Charity Speak and her husband Andrew M. Speak of Grant Co., Ky. sold two tracts of land, lying on Martins Creek in Lee County. Virginia, one tract deeded to her by her father, John Chance, April 20, 1846, and the other deeded by Aldmon Oaks, to Edmund Pace for \$300. (DBK 16-18)

(1) Levi Chance (son of John and Mary) was born in Johnston County, North Carolina, April 18, 1803; died 1889 in Lee County, Virginia. He married about 1828 Rachel Bartley, b. May 3, 1805 in Greene County, Tenn

Levi Chance purchased, Sept. 15, 1837, 200 acres of land lying on the East Fork of Four-Mile Creek, a branch of Powell River from Leander and

Mary Wilson for \$450 (DBK 7, 337).

January 15, 1847 Levi and Rachel conveyed this land to Charles Noe for \$1000 (DBK 10, 352).

Nathan Morgan and wife Martha (Patsy) sold 278 acres (reserving 2 acres lying around the Camp Ground) lying on Indian Creek in Lee County for \$1100 to Levi Chance, Feb. 16, 1847, (DBK 10, 366).

# Will of Levi Chance:

In the name of God and in the presence of these witnesses and calling to mind the uncertainty of human life, and being desirious of making disposition of such property as it has pleased God to allow me to possess. Being of sound mind and disposing memory I make the following disposition of my property, viz., I will that after my death my wife Rachel shall have full control of all my lands and personal property during her life provided she shall outlive me and after my death and the death of my said wife I will that my sons John, Uriah. Stephen, Samuel, Peter and Hugh, and my daughters Nancy, Mandy, Charity Combs, Rachel Edds shall each have an equal part of my real and personal estate. I will that the part left to my daughter Charity Combs shall be used and controlled by her alone. I will to the children of my daughter Cealina the wife of Elisha Combs an equal share of my said estate with my other heirs my said daughter Cealina nor my Son in law Elisha Combs is to have no control of the part willed to their said children.

I hereby appoint H.C.T. Richmond to present this my last will to the Honorable Court to be recorded
